- Arjunchaupari Rural Municipality has allocated funds towards the cost of upgrading of Arjunchaupari-Ward no.3,4 and 5 rural road and intends to apply part of the funds to cover eligible payments under the Contract Identification No ACRM/NCB/W/RD/06/2076/077 Bidding is open to all eligible Nepalese Bidders.
- 2. Arjunchaupari Rural Municipality, *Office of Rural Municipal Executive* invites electronic bids from eligible bidders for the <u>Upgrading Of Arjunchaupari</u> –Ward no 3,4 and 5 Rural Road under National Competitive Bidding Single Stage Two Envelope Bidding procedures.

Only eligible bidders with the following key qualifications should participate in this bidding:

- Minimum Average Annual Construction Turnover of the best 3 years within the last 10 years: NRs. 44,350,000 (Fourty Four millions Thirty Five thousands) excluding VAT.
- Minimum Work experience of similar size and nature: Successfully or substantially completion of one Road project having Concret Work 160.98 cum Stone masonary-691.64 cum Gabbion Box -432 cum And Reinforcement Work -1.86 metric ton. with the value of 18 (Eighteen) millions excluding VAT.
- 3. - 6. Pre-bid meeting shall be held at **Arjunchaupari Rural Municipality**, **Office of Rural Municipal Executive**, at **Arjunchaupari Syangja at November 5, 2019**, Time:- **13.00 hrs**
- 7. Electronic bids must be submitted to the *Office of Rural Municipal Executive*, at Arjunchaupari *Rural Municipality*, Arjunchaupari Syangja through PPMO's e-GP system www.bolpatra.gov.np/egp on or before 12.00 hrs of 19 November 2019. Bids received after this deadline will be rejected.
- 8. The Technical bids will be opened in the presence of Bidders' representatives who choose to attend on 19 November 2019 at 13.00 hrs in the Office of rural Municipal Executive, Arjunchaupari Rural Municipality, Arjunchaupari Syangja. Bids must be valid for a period of 90 days after bid opening and must be accompanied by a bid security or scanned copy of the bid security in pdf format amounting to a

- minimum of NRs.631,000(Six hundred thirty one Thousands only), which shall be valid for 30 days beyond the validity period of the bid.
- 9. The price Bid will be opened after evaluation of Technical Bids. The e-GP system will send the e-mail notification to bidders whose price bids which have been found substantially responsive Technical Bids and who have been determined as being qualified for award to attend the opening of the Price Bids.
- 10. If the last date of purchasing and /or submission falls on a government holiday, then the next working day shall be considered as the last date. In such case the validity period of the bid security shall remain the same as specified for the original last date of bid submission.
- 11. Matters not covered in this notice shall be treated in accordance with PPA-2063 and PPR-2064 (with their revisions).
